Birthday Facebook Fundraiser: Supporting Sokol Minnesota as a Center for Czech and Slovak Families Living in the Twin Cities

Many people do fundraising on their birthday to support a variety of societies and non-profit organizations. When my birthday approached, I wondered how to use social media to

organize a fundraiser for a cultural organization. As a Slovak citizen living abroad, it is very important for me to stay connected with the Slovak and Czech community's language, customs, culture, and events. I do not think one will ever forget the country he/she came from, but one can sometimes feel lonely or disconnected while living abroad.

I lived in New York City for 11 years, where I was a member of the Limbora Slovak Folk Ensemble. I met with my fellow Slovak dancers once a week to practice and we performed at cultural events. After I switched careers and moved to Mississippi for doctorate studies, I immensely missed being connected to a Slovak community. Those five years were hard and long. I moved to Minnesota about two and a half years ago to complete a fellowship in child clinical psychology. I was ecstatic to learn there is the active, vibrant Czech and Slovak Sokol Minnesota organization that offers a variety of events and lessons for adults and children. While I am quite busy professionally in a health care system, I always try to find ways to connect to Slovak and Czech events and people. I even recommend the events to my colleagues and friends.

When it came time for me to decide what organization to choose for my Facebook fundraiser, I did not hesitate. The pandemic is hurting everyone in a variety of ways. The pandemic also significantly endangers the cultural sector, with many organizations struggling hard to stay afloat. Czech and Slovak Sokol Minnesota had to cancel or modify many of its events, to postpone some lessons, or to provide them virtually. I have a five-year-old daughter who understands Slovak, but responds to me in English.

I cannot wait for her to attend in-person Slovak classes again with the Česká a slovenská škola Twin Cities/Czech & Slovak School Twin Cities at the C.S.P.S. Hall and to participate in Christmas and Svatý Mikuláš events. I want her to make friends with other Slovak and Czech children through Sokol. This fundraiser affirms my family's values, helps me to connect to my Slovak culture, and supports Sokol Minnesota during these hard COVID-19 times. I want Sokol Minnesota to survive for its important role in my and my child's and family's mental health and for other Slovak and Czech people who all need to feel part of a community based on their cultural roots while living in a different country. I appreciate everyone who has contributed to Czech and Slovak Sokol Minnesota and who supports our community of immigrants.

Cultural STAR Grant 2020 AwardBy Joyce Tesarek

In response to the COVID-19 pandemic and in a one-time emergency relief program, the Saint Paul Cultural STAR Grant program offered general operations grants in late 2020 to qualified Saint Paul-based arts or cultural organizations.

Awards from \$5,000 to \$30,000 were based on certain types of organizational expenses for the period March 1 to September 30, 2020. Income was also evaluated for that time period compared to similar months in 2019 in order to calculate total loss of revenue.

Our annual building expenses are basically fixed and due even though the C.S.P.S. Hall is closed. Building costs for

2019 were \$86,935 (includes \$21,858 utilities and \$20,860 property tax and insurance). These totals do not include building improvements. Only \$41,575 of Sokol's expenses from March 1 to September 30 were eligible to be considered for the grant.

Income loss was also considered in the grant determinations. Following state health department guidelines, the Hall has been closed and all our regular programming activities and events have been canceled

or, when possible for certain events, made virtual or curbside. Our tenant restaurant Pajarito has also been closed or restricted; we have waved several months of its rent. Sokol sponsors a charitable gaming site in Keenen's Bar. With the bar's restrictions, that revenue has also been reduced, as has rental of the Hall for outside events. In the six months considered, Sokol revenue from events and donations dropped to \$59,201 compared to \$161,456 in the same period in 2019. This was a loss of \$102,256.

Using these figures, St. Paul awarded Sokol Minnesota a grant of \$30,000. Our thanks to the city of Saint Paul for its support!



Highlights of the Sokol Minnesota Board Meetings

November: The online meeting was called to order November 20 at 6 p.m. by President Dave Stepan.

Judy Aubrecht reported on Rentals and Publicity. Dawn Bulera has been at the Hall several times per week organizing rental materials and cleaning. Austin Palma will take over our publicity duties.

Glynis Grostephan, Correspondence Secretary, reported we had a total of \$1,906 in donations in October, plus an in-kind donation from Doreen McKinney.

Pat Slaber, Education Chair, reported the *Ahoj* magazine (for Czech language students) accepted our article and will be published in its December issue. We will submit the article for the *Slovo* in both Czech and English. The straw ornament classes are nearly sold out. We will share Joe Landsberger's talk

presented by Czechoslovak Genealogical Society International, *A Hall in St. Paul*, on January 7 at 7 p.m. via Zoom; registration is required.

Steve Ernest, Financial Secretary, reported our current membership is 286. Norm Petrik reported we added 11 new members in 2020.

Don Haselbauer submitted the treasurer's report. \$29,434 was received this year from individual donors. A motion was carried to send the Annual Gaming Report to the State of Minnesota.

Mary Cahill and Jason Brozovich reported our gymnastics classes continue to be on hold due to COVID regulations.

Bob Kotek, Board of Trustees, reported the buildout for the drainage

improvements on the north side of the building is completed.

Joyce Tesarek, Board of Budget and Finance, recommended to waive the rent for Parajito in January, but still have them responsible for water and taxes, motion carried.

Ed Hamernik reported on Gaming. The motion carried to transfer \$7,000 from Gaming to the General Fund. The motion also carried for a bonus to Steve Shimer of \$500 for his extra efforts with the Gaming Committee.

Dave Stepan, President, reported the Automated External Defibrillator (AED) unit is on hold pending additional donations. Motion carried to purchase three bike racks with the Sokol Minnesota Logo for \$1,400.

The meeting adjourned at 7 p.m.

December: The Czech and Slovak Sokol Minnesota monthly meeting was called to order online by President Dave Stepan on December 17, 2020, at 7 p.m.

Judy Aubrecht reported on Rentals and Publicity. We currently have three musical groups practicing at the Hall. Rentals for late in 2021 are on the Calendar. Austin Palma is the new Publicity Committee chair.

Corresponding Secretary Glynis Grostephan reported donations received this month between the General and Legacy Funds totaled \$3,832. The online auction proceeds totaled \$2,003.

Pat Slaber reported on the archives project. The language classes will resume in spring. Two online cooking classes are planned for 2021: *svičková* and *knedlíky*.

Financial Secretary Steve Ernest nominated five people for membership and they were approved. Renewal letters for 2021 have been mailed.

Norm Petrik, Membership Chair, reported our current membership is now 291.

Don Haselbauer gave the Treasurer's Report.

Joyce Tesarek, Board of Finance reported many grants and donations were received in 2020 and expressed thanks to all who contributed to Czech and Slovak Sokol Minnesota.

Mary Cahill stated for the Board of Instructors that classes are scheduled to resume in January subject to state regulation due to COVID-19. Mary is looking for funding to cover cleaning equipment expenses to ensure the safety of our students.

Bob Kotek reported for the Building and Properties Trustees Committee. New temperature control software has been installed in the C.S.P.S. Hall. The cleaning schedule has been cut back to twice a month because fewer activities and events are allowed during the pandemic.

Jean Draheim, Activities Director, noted the Hall Calendar is being worked on. An outdoor flea market is currently scheduled for April 30 and May 1, 2021. A volunteer appreciation picnic may be held in the summer to take the place of our annual Holiday party.

Gaming Chair Ed Hamernik reported only outdoor gaming is allowed until state COVID control restrictions are lifted. Gaming will hopefully be resumed in January.

President Dave Stepan said he is obtaining bids for window repair on the third floor.

The West 7th Streetcar Committee meetings have started; a Sokol Minnesota representative is needed. It is a three-year commitment. The streetcar line will impact Sokol since it will run on the street in front of the building. The new awning has been installed and looks great! In 2023 we will celebrate the 130th anniversary of composer Antonín Dvořák's visit to the C.S.P.S. Hall. Dave requested members start planning events.

The new office space on the first floor is completed. We will convert the water

fountains on the second floor to bottle filling stations for safety.

The Board members each wished everyone "Veselé Vánoce and Šťastný nový rok"!

The next meeting will be the Annual Board Retreat at a date to be determined.

The meeting was called to order on November 20, 2020, at 7 p.m. The Pledge of Allegiance was recited and a moment of silence was observed for members who passed away in 2020. Election of Board members was held. See the separate article (below) on the election results.

President Dave Stepan stated that our membership has remained strong. The physical condition of the C.S.P.S. Hall is improving. This year has presented many challenges due to COVID. Our programs have shifted to curbside and virtual events and they have been successful.

Don Haselbauer gave the Treasurer's report.

Membership: Norm Petrik noted we had eleven new members in 2020.

Financial Secretary Report, Steve Ernest stated we have 286 members. Members with membership anniversary intervals ranging from five years to 55 years were recognized and thanked for their commitment to the Sokol Minnesota community. (See page 8, December 2020 *Slovo*.)

Board of Budget and Finance: Joyce Tesarek reported on total income and expenses for the period November 2019 to October 2020. She highlighted income from gaming and grants.

Board of Trustees chair Bob Kotek recognized all of the members on the Board for their help in maintaining the Hall. Projects completed in 2020 include new support beams on the first floor, new basement stairs, remodeling of the first floor to

provide an office, support beam in the bar area, sand and refinish floors on first and second floors, added a separate water meter for the restaurant, fixed water drainage problems on the north exterior, installed three dehumidifiers in the basement, ordered a new awning for the front, and proposed a grand reopening of the Hall when deemed safe as per COVID situation.

Board of Instructors: Jason Brozovich and Mary Cahill reported the gymnastics programs are on hold until 2021. Instructors have completed "Safe Sport" training as required by the State of Minnesota. A grant from American Sokol is pending for cleaning supplies, thermometers, etc., needed due to COVID.

Gaming: Ed Hamernik stated charitable gaming was shut down from March to June and again in November. Gaming donated \$25,000 to the General fund in 2019 and \$15,000 in 2020. Electronic gaming has been successful.

Judy Aubrecht was appointed to chair both the Planning Committee (Ed Hamernik was the long-time chair) and Rental Committee.

We currently have a great group of people on the BOD who bring different opinions on topics, can discuss in a respectful way, and come up with decisions all can accept. We all are working well with the COVID restrictions on us and our activities. In these challenging and changing times, we feel continuity on the BOD is helpful.

The election was held at Sokol Minnesota's November 20, 2020, online Annual Meeting. No term limits were reached. Most of the Board members re-elected are continuing in their same positions with two changes. Ed Hamernik resigned his position as First Vice President. He is continuing as Gaming Manager. Sokol Minnesota Welcomes New Members By Steve Ernest



Sokol Minnesota Bylaws Updated By Steve Ernest

Several adjustments were made last fall to Czech and Slovak Sokol Minnesota's Bylaws. Some of the changes clarify how we operate, including formalizing as permanent committees the Board of Instructors, Planning Committee, and Rental Committee. The Finance Chair and the Activities Director were given increased status by making them elected positions by Sokol's members, the same way other Board members are elected. The provision for an Executive Committee of the Board of Directors was removed because it has not been needed.

To reduce the number of boards and more closely follow the standards used by the American Sokol Organization, the Board of Trustees was renamed the Building and Property Trustees Committee and the Board of Gaming was renamed the Gaming Committee to reduce the number of boards and more closely follow the standards used by the American Sokol Organization. Information was added to describe committee responsibilities and inter-relationships as well as Honor Award memberships and Honorary (50-year) memberships. Provisions were added to allow for electronic versions of our records and to require two signatures for all contracts we enter into. Other changes make the Bylaws more informative to members and easier to understand.

Al Milgrom Obituary

Albert "Al" Milgrom passed away peacefully on December 20, 2020. He was born November 21, 1922, to Jewish Russian immigrants and grew up in Pine City, Minnesota. He served in the United State Army during World War II and worked as a journalist for many prominent publications after the war. He is survived by his sister, Elle Stern; children Jacalyn Lechner, Marsha, and Ben; and grandchildren.

Al was a frequent visitor to Czech and Slovak Sokol Minnesota events and activities including taking Czech language classes, often with his camera at the ready. His 2019 film Singin' in the Grain: Minnesota's Czech Story is centered on the Ed Shimota family of Veseli, in Minnesota's Czech Country, beginning in 1974. It is a very touching documentary of a family and their friends and neighbors who value their bond to each other, to music, and to their Czech heritage. The film mixes in scenes from the C.S.P.S.

Hall featuring Sokol Minnesota members, including activities and interviews, the Saint Paul Czech and Slovak Folk Dancers, Sokol Minnesota's Czech and Slovak Festival, children's holiday parties, and the 100th anniversary celebration of of the founding of Czechoslovakia. The film addresses the question: "What does it mean to be Czech?" In short, the answer is: faith, family, hard work, food, music, and "good times"! BOOK REVIEW Czechoslovakian TV as Propaganda for Communist Normalization By Gwen Willems, Ph.D.

The Greengrocer and His TV: The Culture of Communism after the 1968 Prague Spring by Paulina Bren, Cornell University Press: Ithaca and London, 2010. 264 pages. Available at libraries and bookstores.

In *The Greengrocer and His TV: The Culture of Communism after the 1968 Prague Spring* historian Paulina Bren investigates Czechoslovakia's normalization period, 1969-1987. Normalization, as named by the communist government, was characterized by a return to conditions before the reform period of Alexander Dubček, with first of all the firm rule of the Communist Party of Czechoslovakia, and subsequent preservation of the new status quo.

Bren's main hypothesis is that communists successfully used TV serials to communicate an idealistic view of the regime and of citizens who had turned inward, living quiet lives. State television helped create what Bren calls a nation of private persons not publicly active, but "joined in the mutual quest for the good life, which the regime insisted, could best be had under communism."


The title of the book refers to the everyman character in Václav Havel's *The Power of the Powerless* who Bren also sees in the television serials during normalization. Havel tells of an everyman greengrocer who receives a political banner saying, "Workers of the World Unite!" along with the day's shipment of carrots and potatoes. He puts up the banner without thinking twice about it. To Havel this was compliance, supporting the regime, and living in fear. In a Radio Prague interview (July 1, 2019), Bren said, "[Havel] hopes for the greengrocer to take a stand, but I think it was more complex than sometimes Havel realized." Havel urged Czech citizens to stop playing the game and "live in truth."

Bren writes instead about what she describes as "the gray areas" of normalization. "My book also deals with the question of why did [dissidents] have so little resonance within Czechoslovakia among ordinary citizens," she said. Dissidents may have seen citizens' status as a binary opposition - you are with the regime or you are against it. Instead, Bren believes, "There was a spectrum, a very large spectrum, of collaboration during normalization. [To] just exist and function, you had to be somewhere on that spectrum." People could and did quite easily co-exist with normalization, per Bren, who considers normalization a more benign form of authoritarianism than Stalinism.

We know the dramatic stories about the popular Radio Prague offices being shut down when Warsaw Pact tanks and troops thundered into Prague in 1968. The media prominence of radio shifted to television soon after that. The communists learned that citizens were switching off the state television news, which was dull and uninteresting, so they moved their messages into entertainment productions instead. Popular television serials written by Jaroslav Dietl were powerful tools for this. They offered political and social themes "refracted through the private lives of a group of fictional characters and their problems in life, work, and love," per Bren. The serial writer Dietl, who was brought back into favor after supporting the Prague Spring, had the ability to grab readers, making everyday life under the communist regime seem both intimate and appealing.

The Greengrocer and His TV details Dietl's career and the normalization-era television series he wrote, including

Dispatcher, The Thirty Adventures of Major Zeman, The Youngest of the Hamr Dynasty, The Man at the Town Hall, The Woman behind the Counter, The Engineers' Odyssey, and Chef Svatopluk's Quandaries. Bren's book has a helpful introduction, as well as extensive notes, a bibliography, and index. Based on her Ph.D. dissertation, it is written in a dry, dense, academic style. One major drawback is that the book has a mostly Czech and



Prague perspective that leaves out significant Slovak details which should have been explained by the author.

Paulina Bren was born Pavlína Břeňová in Brno. When her family escaped Czechoslovakia in September 1969, she was an infant, normalization was starting, and the borders were about to be closed. She is currently an adjunct associate professor of international studies at Vassar College and her latest book is *The Barbizon: The Hotel that Set Women Free (Simon & Schuster, Spring 2021)*.

Czech Honorary Consul News

February 2021

It was five years ago on December 5, 2015, that I was installed as Honorary Consul of the Czech Republic for Minnesota, Iowa, North Dakota, and South Dakota. My second five-year appointment by the Czech Ministry of Foreign Affairs has been approved and extended to 2025. It continues to be both my honor and my privilege to hold this position.

The services provided by a Czech Honorary Consul are many and varied. The Honorary Consul is a Czech notary. The responsibility that I most often perform is the authentication of signatures for legal documents to be used in the Czech Republic. Each person requesting an authentication must show identification, both a passport and a current driver's license. I create an informational 2"x4"sticker that is attached to the document. A rubber stamp, inked in red, is placed half-way on the sticker and half-way on the document. Finally, I write my signature across the top of the stamp in black ink. During this pandemic, everyone who comes to the Honorary Consul office, located in C.S.P.S. Sokol Hall, must wear a mask and gloves.

Passing out new or renewed passports is my second most frequent task. This is a recent procedure, which has been well-received by Czech citizens. To renew/obtain a Czech passport, first the applicant has to go to a Czech Consulate General (Chicago, New York, or Los Angeles) or the Embassy in Washington, D.C. Since 2016, the new passport can be picked up at the local Honorary Consul Office. This is great convenience, especially for those who live a long distance from their

Consulate General; for example Czech citizens in Alaska no longer need to make two trips to Los Angeles.

Czech Honorary Consuls are located in 24 cities in the United States. Reporting to Chicago are Sharon Valasek in Kansas City, Mila Saskova-Pierce in



Lincoln, Nebraska, and myself here in Minneapolis/ Saint Paul. Jan Kubišta, who is both the Consular Officer and the Deputy Consul General at the Consulate General/Chicago, is a valuable source of information and support.

I am often asked: How do I apply for a visa to study in the Czech Republic? Can I obtain Czech citizenship if my parents/grandparents were born in Czechoslovakia? Do you have travel information for the Czech Republic? An Honorary Consul can help a Czech citizen should they find themselves in a difficult situation. An example is the case of an expired passport and the emergency need to return to the Czech Republic. The Honorary Consul can issue a temporary passport, which is valid for two weeks; this is considered sufficient time to return to the Czech Republic and apply for a new passport. Honorary Consuls also try to connect entrepreneurs in their states with CzechTrade and CzechInvest.

The added bonus of being an Honorary Consul is the opportunity to support and promote Czech cultural

opportunity to support and promote Czech cultural activities, organizations, and events, as well as to exchange ideas with Honoraries from other countries. The Minnesota Consular Corps has over 60 members representing 34 countries.
